

**LAMONT COUNTY
NO SPRAY APPLICATION AGREEMENT**

1. I acknowledge my duty to maintain the portion of the road right-of-way that lies between the boundary of my property and the centre line of the adjacent road(s) free from all noxious or restricted weeds.
2. I understand that if any noxious or restricted weeds and/or brush persist within the Lamont County right-of-way and are determined by the Agricultural Fieldman or his designate to be unacceptable, then I, as owner of the land within the "No Spray" zone limits, shall be notified by Lamont County and shall have a set period of time in which to control the weeds in a manner acceptable to the Agricultural Fieldman or his designate, failing which Lamont County shall take whatever steps it deems appropriate to control weeds, which many include herbicide application.
3. I also understand that the County road right-of-ways shall not be used as a shelter belt or buffer zone for sensitive area(s) or vegetation.
4. I agree to the following guidelines for signage of the requested "No Spray" zone:
 - a) Lamont County will supply "No Spray" signs as per Policy No. 6064.
 - b) "No Spray" signs must mark the requested "No Spray" zone limits and be located at the corners of the property on the property line adjacent to the County roadway (approximately 6 meters in from neighbouring properties). "No Spray" signs must be fixed to a fence post or separate post at a height of 1 metre (minimum) to 1.8 metres off the ground, in an area visible from the road at a 45° angle to the road traffic. Signs will not be located on the road shoulder.
 - c) It is the owner's responsibility to ensure clear visibility of the signs from the road during the months of June through October of every year until termination of this "No Spray" Agreement.
