This position reports directly to the Operations Manager and performs a variety of labour-intensive tasks for road maintenance and construction.

### **JOB DUTIES AND RESPONSIBILITIES:**

- Manual tasks of all types across all operations (cleaning and steaming culvert ends, patching, pothole repairs, signage, guard rails, flagging, garbage, tree clean up, etc.).
- Operates County vehicles and light equipment including small tractors, trailers, etc.
- Assists with flood control and repair.
- Assists with the maintenance of County buildings and landscaping (grass mowing, snow shoveling, etc.).
- Compliance with the Lamont County health and safety program.
- Accurate recording and submission of weekly timesheets.
- Other labour related duties as assigned.

### **QUALIFICATIONS AND REQUIREMENTS:**

- Experience in labour work and light equipment operating.
- High School Diploma or GED.
- Holds a Class 5 Alberta Driver's license.
- Ability to lift approximately 50 lbs., sit for prolonged periods, and climb in and out of equipment.
- Ability to work in all types of weather (rain, cold or hot) and dusty conditions.
- Willing to work 10-hour days, overtime may be required on occasion.
- Safety conscious and attentive to the working environment they are in.
- Excellent public relations and communication skills are required.
- Ability to work independently and unsupervised.
